

**KETTLE MORaine ROUGH RIDERS DRILL TEAM HORSEBACK RIDING  
WAIVER & RELEASE OF LIABILITY**

**FOR THOSE UNDER THE AGE OF EIGHTEEN (18)**

**1. THIS IS A LEGALLY BINDING CONTRACT;**

In consideration of being permitted by the Kettle Moraine Rough Rider Drill Team, "KMRR" to ride horses and participate in the Kettle Moraine Rough Riders Drill Team Competition, I agree to the following Waiver and release and I make the following representations : \_\_\_\_\_(Initial)

**2. I HEREBY ACKNOWLEDGE THE INHERENT RISKS IN HORSEBACK RIDING;**

I understand that riding horses is an inherently dangerous undertaking in that a horse may kick, move or otherwise physically react at anytime to contact from a human and that KMRR cannot predict how any horse will react or respond to human contact: \_\_\_\_\_(Initial)

**3. I VOLUNTARILY AGREE TO ASSUME ALL RISK OF PERSONAL INJURY;**

I voluntarily assume all risks of horseback riding which may cause personal injury with full knowledge and appreciation of the danger and risk involved. I voluntarily agree to assume all risk of personal injury, including paralysis and death, that may occur while I am participating in the Kettle Moraine Drill Team Competition or while I am preparing to ride a horse or in the process of riding a horse or have completed riding a horse at anytime, whether or not under the supervision of KMRR personnel: \_\_\_\_\_(Initial).

I hereby knowingly and intentionally waive and release, and agree to indemnify, hold harmless and defend, KMRR, its members, employees and agents, and it's successors and assigns, from all liability for any personal injury, paralysis, or death, or any other damages which may result from my participation in the Kettle Moraine Rough Riders Drill Team Competition: \_\_\_\_\_(Initial)
